1. Call to Order

Victor Hermosillo stated that having a sample spec might create issues by accidentally introducing limitations (e.g. if the sample spec says hydraulic mech and the user copies the spec word-by-word instead of using it as a template, then manufacturers with spring mechs may be excluded). The solution would be to make the sample spec generic by leaving fields blank where applicable
- d. Removal of C37.06 as a reference since it's superseded by C37.04: This shall be done in the document wherever applicable
- e. Terry Woodyard suggested that we convene with the WG Chair of the previous revision to check if there are any unfinished items which can be addressed in this revision John Webb will be added to the workspace so that he can add any pending items.
