

**Minutes of the Meeting of the Board of Governors (BOG)
Of the
IEEE Society on Social Implications of Technology (SSIT) (SIT-30)
at
Arizona State University
Tempe, AZ**

18 October 2008

1. Welcome and Introductions

9. Conference Committee Report (G. Hoffnagle)

The Conference Committee held a telephone conference call on 17 October to discuss conference matters.

ISTAS 08 – The surplus is expected to be close to \$12,000. The experiment of requiring full papers for inclusion in the conference proceedings was regarded as a success in bringing in high quality papers.

ISTAS 09 – This will be a joint conference with the IEEE Technical Committee on Sustainable Systems and Technology and will be held in Tempe AZ from 18-20 May. The theme will be "Social Implications of Sustainable Development". Attendees will pay one fee and then attend sessions of either group. Planning is in progress for 230 attendees and five concurrent presentation tracks, with joint keynote speakers and

meals. Clint Andrews is the Program Chair. Authors will be required to provide full papers for review in order for their papers to be included in the conference proceedings.

ISTAS 2010 – The conference will be in Australia, centered on the University of Wollongong. Dates are being discussed, as is the theme. An organizing committee has been formed with Dr. Katina Michael as the chair.

ISTAS 2011 – This conference is planned for a North America location. We need a volunteer to start planning and a location.

No money will be required but we will be eligible to have a representative on the Award committee. An electronic vote will be taken.

O’Connell Fund Donation. Jerry Engel moved that SSIT donate \$500 to the Central Connecticut State University Brian O’Connell Fund. An electronic vote will be taken.

The group thanked Sarah Pfatteicher for her service to SSIT; her term on the Board ends on December 31 2008.

Next meeting. January 31 was chosen as the date, with the meeting to be in the Washington, DC, area.
